INTRODUCTION

- ✓ Right to rectification: You have the right to have your personal data completed, corrected, deleted or blocked at any time.
- ✓ If you have consented to the processing of your data, you have the right to revoke this consent and delete your personal data.
- ✓ Right to data portability: you have the right to request all your personal data from the controller and transmit it in its entirety to another controller.
- ✓ Right to object: you can object to the processing of your data. We comply with this unless there are legitimate grounds for processing.
